Bylaw No. 553

BYLAW NUMBER 553 OF THE VILLAGE OF FERINTOSH IN THE PROVINCE OF ALBERTA, BEING A BYLAW TO REPEAL BYLAW NO. 521 AND BYLAW NO. 540, AND BEING REPLACED BY THIS BYLAW, TO AUTHORIZE THE RATES TO BE LEVIED WITHIN THE VILLAGE OF FERINTOSH FOR THE PROVISION OF WATER AND WASTEWATER UTILITIES AND GARBAGE COLLECTION SERVICES

WHEREAS, THE MUNICIPAL GOVERNMENT ACT, R.S.A. 2000, c.M-26, AS AMENDED, ENABLES A COUNCIL OF THE VILLAGE TO PASS BYLAWS RESPECTING PUBLIC UTILITIES AND TO PASS BYLAWS RESPECTING SERVICES PROVIDED BY THE MUNICIPALITY;

NOW THEREFORE, THE MUNICIPAL COUNCIL OF THE VILLAGE OF FERINTOSH, IN THE PROVINCE OF ALBERTA ENACTS A BYLAW REFERRED TO AS THE “UTILITY AND SERVICE RATES BYLAW.”

For the purpose of this Bylaw every person who is the registered owner, or the purchaser entitled to possession under an agreement for sale, or the occupant of the property served by a connection with the water distribution system, the wastewater collection and disposal system, or serviced by garbage collection shall pay the rates as set out in this Bylaw.

1. A charge shall be made monthly for the use of the water supply and distribution system and the consumption of water according to the rates hereinafter set out.
 - a) for maintaining a connection to the water supply and distribution system, a charge of five dollars (\$5.00) per month, and
 - b) for all water consumed, an additional charge of four dollars (\$4.00) per cubic meter, and
 - c) for rental of the water meter, an additional charge of one dollar and fifty cents (\$1.50) per month.

2. A charge shall be made monthly for the use of the wastewater collection and disposal system according to the rates hereinafter set out.
 - a) for the first 11.36 cubic meters of water consumption a minimum charge of fifteen dollars (\$15.00) per month, and
 - b) for all usage above the first 11.37 cubic meters of water consumption, an additional charge of one dollar and fifty cents (\$1.50) per 4.54 cubic meters.

3. A charge shall be made monthly for garbage collection and disposal according to the rates hereinafter set out.
 - a) for collection and disposal of garbage, a charge of eight dollars (\$8.00) per month.
4. These charges shall be billed monthly.
5. Overdue accounts may be added to the tax roll when the account is ninety (90) days past due.
6. This bylaw shall take effect on the date of the third and final reading.

Read a first time on this 9th day of July, 2008.

Read a second time on this 9th day of July, 2008.

Read a third time and passed on this 13th day of August, 2008.
